# About PRE-AND-POST TRIAL

PRE-AND-POST is an **Italian judicial Network**, led by the District Prosecution office of Venezia, Italy, focusing on **alternative measures** to detention in the pre-trial phase (FD 2009/829/JHA in relation to art. 12 of FD 2002/584/ JHA) and during penal execution (CD 2008/947/JHA).

The PRE-AND-POST Network aims to foster **knowledge**, share **experience** and common **tools**, exchange **information** and implement **training** activities with a bottom-up approach.

The project uses a **grassroots** and **multilevel methodology** for the networking, which evolves gradually from the local to the national level and, eventually, bridges national efforts to those made at EU level.



# The Context

Almost all the EU Member States have now formally transposed the FDs 947 and 829. Nonetheless, the fact of being transposed into the national legislation does not automatically indicate that these FDs are being used correctly and effectively in practice.

According to data by EJM about the application of European legal instruments based on mutual recognition in criminal matters, both FD 947 and 829 are underused.

Member States EJM contact points exposed various obstacles which prevent the use of these FDs:

- A lack of information and knowledge about these instruments among practitioners;
- The fact that the procedure is too complicated or provides a big administrative burden;
- The disparity of alternative measures and services in different Member States;
- The difficulties in getting the required consent of the accused people;
- The costs, or the question of the proportionality – since the cases concerned by the FD 947 and/or 829 often concern minor offences.

The level of implementation of the FDs 947 and 829 is far from satisfactory, and sometimes the transposition is partial and incomplete, formally adopted but underused in practice, while relevant cultural problems impact on the effectiveness of the instruments supporting non-custodial measures in the pre-and-post trial phases.
